

Main Line Broadcasting Pepsi Rock Band Official Rules and Regulations

1. To be entered in the Pepsi Rock Band Tournament contest, participants must follow specific contest instructions and adhere to general rules and regulations.
2. Participants must be 18 years of age or older to participate and win.
3. Contestants will play Rock Band at specified locations for a chance to win.
4. Each participant will play individually a song to be chosen by WDHT Hot 102.9 staff at a difficulty level to be chosen by WDHT Hot 102.9 staff.
5. Each participant will play guitar only. No other Rock Band provided instrument may be used.
6. Each participant must use the Rock Band guitar provided by WDHT Hot 102.9 at each round of the tournament.
7. Two rounds will be played. One on July 8th, 2009 from 7-9pm EST at Adobe Gilas in the Greene, Dayton, Ohio. The second will be at Splash Moraine July 17th, 2009 from 5-7pm EST.
8. The participant with the highest score from each round will move on to play for the grand prize at the final round July 20th, 2009 at 5/3 Field during a Dayton Dragons baseball game. Time TBD.
9. Each winner in the first two rounds will win a certificate from Game Stop Dayton good for one copy of the soon-to-be released Beatles Edition of Rock Band.
10. The grand prize game will be played in the same manner as listed above for the first two rounds. Two players will play a pre-selected song on guitar only at a pre-selected difficulty level. The player with the most points after one game wins.
11. The grand prize winner will receive round trip airfare for themselves and one guest, hotel stay, and two tickets to the MTV Video Music Award Pre-Party in New York City.
12. No one may win more than one of each prize offered.
13. No more than 1 winner per household may win a specific contest.
14. Winners of cash or merchandise prizes may not win another prize of cash or merchandise within 30 days. If prize exceeds the value of \$1000, winner may not win anything from any Main Line Broadcasting station for one year.
15. Winners have 30 business days to pick up their prize, if prize is not picked up within 30 business days; the prize is returned to the Main Line Broadcasting prize inventory and is forfeited by the winner.
16. Winners must be a resident of Ohio to be eligible to play contests.
17. For prizes that are mailed, allow a minimum of 10 business days before delivery. With the majority of our prizes being specific numbers, we will not be able to re-mail or replace prizes that do not reach the winner in the mail.
18. All other prizes must be picked up at the Main Line Broadcasting studios during regular business hours, Monday-Friday from 8:30am-5:30pm.
19. Winners are solely responsible for payment of all applicable federal, state, and local taxes, if any.
20. Winners must be at least 18 years of age and must present a valid ID to receive a prize.
21. Only one entry per person, subject to specific contest/game rules.
22. To be awarded a prize, the name drawn or contestant chosen, or correct caller, must be the proper name of the contestant, according to specific contest rules, as determined by Main Line Broadcasting.
23. Main Line Broadcasting is not responsible for any mechanical telephone problems or failure, facsimile transmission problems or failure, email and/or website difficulties, omission or neglect on the part of the US Postal service.
24. All materials submitted during a contest become the property of Main Line Broadcasting. Main Line Broadcasting shall have the right to use any such material in connection with the given contest in any way seen fit by Main Line Broadcasting. By entering a contest, the participant agrees that Main Line Broadcasting may use his/her name, photo, or voice in advertisements and/or promotion without compensation and grants Main Line Broadcasting all rights said to use.
25. All employees and families of Main Line Broadcasting or its agencies and participating advertisers are ineligible. Employees of radio stations in the greater Dayton MSA, as determined by the Arbitron Company, are also ineligible.
26. No purchase is necessary.
27. Contest is void where prohibited by law.
28. Prizes are not transferable and no substitution of prizes will be allowed.
29. Main Line Broadcasting reserves the right to determine the eligibility of any contestant.
30. Any violation of the above-stated Main Line Broadcasting contest rules will constitute disqualification and no prize will be rendered by Main Line Broadcasting, or its agencies and advertisers.
31. Contest may be discontinued without prior notice.
32. Contest rules may be changed at any time without prior notice by Main Line Broadcasting.
